b. Has there been any change to the number or status of any members in your household?
2. a. Who do you support financially? Do you make support payments?
b. Did you pay for an attendant, childcare provider or any retirement or nursing home costs?
3. Do you or any dependent living with you have a mental or physical infirmity or disability?
4. Did your marital status change during the year?
5. Did anyone in your family arrive in or leave Canada?
6. Did anyone in your family pay for medical expenses this year, other than MSP (MSP is not deductible)?
7. Did anyone in your family attend a post secondary institution, part time or full time?
8. Did anyone in your family pay **private** extended health or dental premiums?
9. Did anyone in your family make donations or gifts to charities?
